## *Celebrating 15 Years*



In the summer of 2009 over 200 residents attended a community meeting and decided to form an organization to represent the community's interest regarding future development in the area. A non-profit association was established, by-laws were adopted, a board was formed and a mission and goals were developed.

Over the years, we have grown and established credibility with elected officials, government agencies and community organizations. FANA works with these groups and many other community members to advocate for sustainable development practices and to promote our position of

Ongoing efforts by FANA include:

- Communicating with local representatives of the Mayor's Office, Metro Council, Office of Planning & Metro Sewer District and the State Legislature, KY Division of Water and KY Transportation Cabinet.
- Advocating for the protection of Floyds Fork creek with the KY Division of Water, MSD, city planners, developers and others.
- Participating in coalitions with similar organizations to strengthen our impact
- Monitoring development proposals and testifying at metro council and planning commission and zoning hearings.

### ***Reflecting on the Past - Looking to the Future***

Over 15 years FANA has many achievements; however, our work continues. Some accomplishments include:

- \* Advocated for code changes to the new Floyds Fork Special Zoning Overlay District
- \* Participated in the development and adoption of the South Floyds Fork Area Plan
- \* Commissioned a study to define actions necessary to fulfill the Area Plan
- \* Participated in amending the Land Development Code to preserve & improve the Tree Canopy
- \* Drafted language & secured inclusion of a new Conservation Form District in Metro Plan 2040

- \* Advocated for amendments to Conservation Subdivisions in the Land Development Code
- \* Supported Friends of Floyds Fork and Future Fund to secure funding for a 12.5-million-dollar US Army Corp of Engineers Rehabilitation Plan for Long Run and Chenoweth Run creeks, part of the Floyds Fork watershed. Two additional sites are proposed for reforestation, one in Fisherville at Hwy 155 and a second in Bullitt County.
- \* Serving on the KY Department of Transportation Community Advisory Board planning for a new I-64 interchange and connector roads
- \* Meeting with KY Division of Water and Metro Sewer District to complete modeling of contamination to Floyds Fork creek and to use this data to guide the MSD 5-year plan and permitting process
